4.1 Canned pet food of animal origin, exported into the Customs Union was manufactured by establishments, approved or registered by the Competent authority in the EU Member State on delivery of goods for export and are under regular control from this Authority.

4.2 Canned petfood of animal origin originates from processing establishments which have not been placed under animal health restrictions and from raw materials derived from animals whose carcasses and internal organs are fit for human consumption according to veterinary sanitary expertise.

4.3 Meat and offal of bovines from which petfood is manufactured are derived from healthy animals that originate from herds where there is no case of Bovine spongiform encephalopathy (BSE) and do not belong to birth cohorts of BSE positive animals.

Meat and offal of sheep and goats for production of petfood of animal origin are derived from healthy animals according to the OIE Animal Health Terrestrial Code recommendations for scrapie.

Specified risk materials (SRM) were removed according to the OIE Code recommendations.

4.4 Canned pet food was subjected to a system of thermal processing ensuring appropriate safety requirements in relation to the established microbiological Standard.

4.5 Canned pet food has undergone all precautions to avoid contamination with pathogenic agents after treatment.

4.6 Package and packaging material are used only once and comply with requirements of the Customs Union.

4.7 Canned pet food of animal origin is legibly labelled on package.

4.8 The means of transport was treated and prepared in accordance with the requirements of the exporting country.
