- 4.1 Feed and feed additives of animal origin, exported into the Russian Federation destined for animal feed were manufactured by establishments, approved by the Competent Veterinary Service on delivery of goods for export and are under constant control from this Service.
- 4.2 Feed and feed additives originate from processing establishments which have not been placed under animal health restrictions and are derived from fresh raw meat of animals (including poultry, fish).
- 4.3 In feed production no proteins of ruminant origin were used, excluding milk proteins.
- 4.4 Raw materials are derived from animals that were not subjected to the exposure of natural or synthetical estrogenic, hormonal substances, thyreostatics, antibiotics, other drugs and pesticides, used prior to slaughter no later than authorised by instructions on how to use them, and were subjected to post-mortem veterinary inspection by State/official Veterinary Service of the country of origin.
- 4.5 The raw material of animal origin has been processed at a core temperature of at least 133 degrees Celsius (271,4 Fahrenheit) for at least 20 minutes at a pressure of 3 bar (42,824 Pounds pr.sq.inch) - or processed by an officially approved alternative system of heat treatment offering equivalent guarantees with regard to microbiological safety.
- 4.6 Feed and feed additives do not contain salmonella, botuline toxin, enteropathogenes and anaerobic microflora. Total bacterial contamination does not exceed 500 thousands of microbial cells in 1 g, what is confirmed by the results of investigations, conducted in the official laboratory on " \_ \_ " \_\_\_\_\_ 200\_.
- 4.7 Packing material is waterproof, used for the first time and satisfies the necessary hygienic requirements.
- 4.8 Feed and feed additives must have a marking or a veterinary stamp on package or block.
- 4.9 Means of transport are treated and prepared in accordance with the rules approved in the EU.
